## **ENDANGERED AND THREATENED SPECIES EXPERIENCE**

- Mr. Everett has advised clients with respect to all aspects of New York State's
   Endangered and Threatened Species Law and related NYSDEC regulations 6 NYCRR
   Part 182 and the Federal Endangered Species Act and related U.S. Fish and Wildlife
   Service ("USFWS") regulations. He has represented residential builders, energy
   companies, religious institutions, private individuals and commercial developers, among
   others, in connection with these regulations.
- Mr. Everett was the lead counsel in developing and implementing one of the largest timber rattlesnake studies in the lower Hudson River Valley. The study area covered two thousand acres in portions of New York State and portions of New Jersey. The study identified previously unknown snake habitat and was instrumental in its preservation.
- Mr. Everett was lead counsel in developing and implementing a large timber rattle snake study in Rockland County which identified previously unknown snake habitat. The study was instrumental in selling the land to New York State for critical habitat protection as a new addition to Harriman State Park.
